Important Information about Your 403(b) Account

Dear Plan Participant:

In order to provide participants in the Roman Catholic Archdiocese of Indianapolis Employees' Tax Deferred Savings Plan ("Plan") with investment options covering a wide range of investment objectives, the retirement plan committee continually monitors and reviews the Plan's investment options. As a result of this review, we are pleased to announce the investment option changes discussed below. The changes will be effective June 15, 2018. In order to implement these changes, there will be a period of time, beginning June 13, 2018 and ending June 15, 2018, during which you will not be able to conduct transactions with your Plan account. This means you will not be able to change your investment elections, transfer among the investment options or take a distribution from the Plan.

What do I need to do?

The blackout period for the Plan is expected to begin on June 13, 2018 and end on June 15, 2018. During the blackout period, you will be unable to direct or diversify the assets held in your Plan account. For this reason, it is very important that you review and consider the appropriateness of your current investments in light of your inability to direct or diversify those investments during the blackout period. Before the blackout period begins on June 13th, you should call the Participant Services Center at 1-800-442-4015 or visit the participant web site at www.archindyretirement.org to review your investment elections and change your future contribution investment option elections for the investment options being retired.

What will happen if I do nothing?

If your current investment election includes any of the investment options being retired and you have not changed your investment election before June 13th, your investment elections for past and future contributions will be “mapped” as detailed below:
